
(II) The purpose of the acquisition and the interest is purely investment

(III) In the name of Norges Bank we hereby notify pursuant to ICVM Rule 358/02 that on 10.06.2011 the shares held by Norges Bank in Millennium Inorganic Chemicals do Brasil S.A. preferred A and B shares (SEDOLS: 2886554 and 2886543) exceeded the 5% threshold and amounted to 75,600,000 preferred A and B shares, equal to 5.01% of the total preferred shares outstanding.

(IV) Before exceeding the 5% threshold Norges Bank held 75,000,000 preferred A and B shares in Millennium Inorganic Chemicals do Brasil S.A., equal to 4.97% of the preferred shares outstanding.

(V) No shareholders' agreement or contract regulating the right to vote or purchase and sale securities issued by the company exists.
